Greetings from Singhania University.

The world is appreciating the hard work and dedication of medical practioners while fighting against Corona Virus (COVID 19) pandemic. Lockdown has also proved to be an effective preventive measure but to deal with the impact and after effects of Covid 19 pandemic; we must promote medical education and remove the scarcity of medical professionals worldwide. Every Hospital with its own tradition, culture and history is recognized as the best entity to promote medical education and healthcare services worldwide.

The Hospitals affiliated with a university to impart training for awarding medical qualification are recognized as "approved institution" under section 2 of The Indian Medical Council Act 1956 and as per section 2 of the NMC Act the affiliated colleges within or outside India which grant degree/diploma in medicine would be considered as "medical institutions".

Section 2 of The Indian Medical Council Act 1956

DEFINITION:

(a) "approved institution" means a hospital, health center or other such institution recognised by a University as an institution in which a person may undergo the training, if any, required by his course of study before the award of any medical qualification to him;

Section 2 of The NMC Act:

DEFINITION

(i) "medical institution" means any institution within or outside India which grants degrees, diplomas or licences in medicine and include affiliated colleges and deemed to be Universities;

Singhania University is established by an act of state legislature that is a statutory body and being recognized under section 2(f) of the UGC Act, it is entitled by authority of law i.e section 12 of the UGC Act to affiliate the hospitals for imparting medical education and to award degrees/diplomas/certificate in all courses under section 22 of the UGC Act read with section 5 of the Singhania University Act which are sui-generis valid for all intents and purposes including Central & State Government Jobs and are also entitled for registration with councils.

Section (12A*)(1) of the UGC Act:

(a) "affiliation" together with its grammatical variations, includes, in relation to a college, recognition of such college by, association of such college with, and admission of such college to the privileges of, a university;

(b) "college" means any institution, whether known as such or by any other name which provides for a course of study for obtaining any qualification from a university and which, in accordance with the rules and regulations of such university, is recognised as competent to provide for such course of study and present students undergoing such course of study for the examination for the award of such qualification;

(d) "qualification" means a degree or any other qualification awarded by a university;

Section 22 of the UGC Act:

RIGHT TO CONFER DEGREES

(1) The right of conferring or granting degrees shall be exercised only by a University established or incorporated by or under a Central Act, a Provincial Act or a State Act or an institution deemed to be a University under section 3 or an institution specially empowered by an Act of Parliament to confer or grant degrees

The medical students of Singhania University will be eligible / entitled to appear in the Exit Exam conducted by National Medical Commission under section 15 of the NMC Act and the medical qualification awarded by the university shall be recognized medical qualification under section 35 of the NMC Act.

Section 15 of the NMC Act:

NATIONAL EXIT TEST

(1) A common final year undergraduate medical examination, to be known as the National Exit Test shall be held for granting licence to practice medicine as medical practitioners and for enrolment in the State Register or the National Register, as the case may be

Section 35 of the NMC Act:

RECOGNITION OF MEDICAL QUALIFICATIONS:

(1) The medical qualification granted by any University or medical institution in India shall be listed and maintained by the Under-Graduate Medical Education Board

or the Post-Graduate Medical Education Board, as the case may be, in such manner as may be specified by the regulations and such medical qualification shall be a recognised medical qualification for the purposes of this Act.

As per the latest amendment notification dated 13.05.2019 University and Hospitals / Societies / Trust / Companies have been permitted to collaborate for running of medical courses.

Hospitals with 100+ beds may apply for Diploma/Certificate courses and hospitals with 200+ beds may apply for Under Graduate/Post Graduate/Diploma courses.
